
I quote from the last paragraph of the Pamphlet 01, attached hereto pages 2 to 7

**ABSTRACT:**

Many years back, many years in modern South Africa, and in particular Soweto, is but only a decade, I was attracted to journalist Dennis Becket's social / political theory on the double "D", Direct Democracy.

I saw this Direct Democracy system, as the equivalent of the pre-1992 Civic Committee structures that had existed in the Townships of South Africa, and I invited Dennis to meet with one of my local Soweto brothers, Bheki Gumbi, their interaction, I believed would educate me.

The one aspect that still rings clear in my mind-set, is Bheki repeatedly claiming that DD could not work, and the words that he used was as follows:

***"No. you are wasting your time, there is no-one to talk to, you have killed all my people."***

Denis could not relate to the concept that Bheki's people had all been killed, as the streets clearly showed the hundreds of people that throng through 'bank-city', I understood Bheki, he considered many of his people to have been killed by the 'white people', in terms of their "minds" and he was finding great difficulty, to comprehend any new topic of discussion.

I understood Bheki, my wife and I had participated in the Township and Village communities for nearly twenty years, and we had not been able to transfer our vision, successfully into any of the groups that we had interacted with.

When and how the local populations mind-sets were 'killed', I did not fully understand, it would take me from November 2019, to November 2024, to understand how the citizens of every country's mind-sets are controlled, how the majority of the white man's mind-sets, have also been 'killed'.

This paper is intended to free the minds of the vulnerable indigenous populations, but hidden among all of these vulnerable indigenous populations, are those dark-skinned persons, who are in fact descendants of the loins of the 'white boss', woman often raped, often exploited by the situation employer / employee / slave, and in many cases, declared love between the parties, all the children, of these encounters, automatically segregated from the white society, by the Power Elite.

The Western World, and not only South Africa, has done the descendants born from the loin of a white man, to a dark-skinned woman, great injury.

In the USA, it was the descendants of the Slave Trade, who adopted the description Colored, (coloured), as part of their claim to being an American, and therefore not an African, who could be relocated to Africa, time would have this description changed to "Black", such change frees the USA White Population, from any responsibility and liability for those descended from the loins of a white man.

In both the USA and Australia, what the Western Capitalist World would like to label as reconciliation and restitution taking place, is a very false reality, and this is clearly shown in the media, following the publication of "The 1619 Project: A New Origin Story," which for the first time gives me real insight into the contribution that the African Slaves make to the economic development of the USA.

When I first read the content, as a "Google Researcher" I am excited, within a few months, notwithstanding the Covid-19 interruption, the 'power elite' starts to hide the truth.

I visited Baba Credo Mutwa regularly from about 2008 till his death, and the African Slave trade was discussed often, Baba was adamant that the African slaves were recruited under false pretences, the African leaders were all told that the slaves were required for a short period and that they would be returned. The failure of the whites to return the slaves when their period was served, was evil, and flies in the face of all African cultural norms.

Baba will quote the many ship-wrecks that take place off the coast of South Africa, and how the black populations were always there to assist, this he says takes place, because the African always expected their families to be returning from across the sea.

When this status is established, when the Capitalist White population, legally declare the black to be subhuman, that the African Slave's indentured status is converted to permanent slave, 1640 to 1660.

Many whites who arrived in North America during the 17th and 18th centuries came under contract as indentured servants.

The transformation from indentured servitude to slavery was a gradual process in Virginia. The earliest legal documentation of such a shift was in 1640 where a black man, John Punch, was sentenced to lifetime slavery, forcing him to serve his master, Hugh Gwyn, for the remainder of his life, for attempting to run away.

This case was significant because it established the disparity between his sentence as a black man, and that of the two white indentured servants who escaped with him (one described as Dutch and one as a Scotchman). It is the first documented case of a black man sentenced to lifetime servitude and is considered one of the first legal cases to make a racial distinction between black and white indentured servants.

**Author Cedric de la Harpe makes findings of importance:**

I submit that, had these restrictions not been introduced,

- 5.1. The present economic position of the descendants of the African slave trade, would be comparable to the economic position of the descendants of the Irish and English indentured labour to the New World.
- 5.2. The following generations of descendants of the African slave trade, would have boarded a ship on the first leg of the 'triangular route' to Africa, alighted in Europe for a sojourn before boarding a ship to Africa, this opportunity, without the 1660s restrictions in place, would have resulted in a European mulatto community.
- 5.3. The descendants of the African slave trade, who arrived back in Africa before the 1870s. would have prevented the Colonization of Africa.
- 5.4. The world would be a different place, and 'black poverty' in Africa would not exist.


